Eligibility:

- Open to artists/photographers of all ages. ALL MEDIA accepted.
- All entries must be original and produced by entrant, no size limitations, under 20 pounds.
- Jury has final authority on eligibility and criteria of entries.

Requirements:

- Submission deadline is **Saturday, October 12, 2024, Midnight**. Please email JPGS of works entered to director@bowenarts.org by October 12. Forward entry fee and Form via email or to Bowen, PO Box 849, Dawsonville, GA 30534.
- **Entry Fee for up to 3 works: Member \$20.00, Non-Member \$25.** Pay through PayPal online, or via cash or check payable to **Bowen, PO Box 849, Dawsonville, GA 30534.**
- All information given on entry form as to title and price must remain same on accepted entry.
- Approved work must be framed and securely fastened with hanging wire (no sawtooth hangers), or suitable hanger according to materials (metal, canvas, etc.) which are compatible with Bowen wall hanging system. Works over 20 lbs. not acceptable. Bowen reserves the right to refuse the display of unsafe or unsuitable work.

Gallery Sales:

The Bowen collects 20% commission on works sold during Show. A 7% Georgia sales tax will be added at point of sale. Prices listed on the entry form are binding. Works not for sale should be listed "NFS." Prize awards based on entry numbers and may be changed at any time at the discretion of the Bowen.

After close of show, any works left at Bowen over 45 days become the property of the Bowen.

Notification:

Jury has authority on eligibility and criteria, and choice of entries exhibited in Show. **Artists will be notified of accepted works via email no later than October 14, 2024.** Additional instructions on artwork drop off dates, etc. will be provided.

A 7% GA sales tax will be added at point of sale. The Bowen collects 20% commission on all works sold during Exhibit. Payment for work sold will be sent within thirty (30) days of exhibition closing date.
- Although the utmost care is taken in handling works, neither the Bowen nor its assigns, will be responsible for damage or loss whatever the cause. Artists are encouraged to carry their own insurance. The Bowen is not responsible for work damaged due to an improper hanging system as mounted on work.
- No work accepted for the exhibition may be withdrawn before the close of the exhibition unless as otherwise arranged between Artist and The Bowen.
- No entry will be accepted without artist's signature on this release. Bowen has authority on dates/times.
